**Re: H.B. 1179**

Dear Representatives Clere, Miller, Zent, and Fleming:

The Professional Certification Coalition (PCC) writes to share our views regarding H.B. 1179. While the PCC supports reducing barriers to employment and decreasing obstacles to worker mobility, we urge an amendment to H.B. 1179 to ensure that Indiana residents can rely on occupational licensing agencies to protect against occupational practice by potentially unqualified individuals.

The PCC is a nonprofit association formed to address legislation that affects professional certification programs, those who hold private certification credentials, and the many constituencies that rely on professional certification. The PCC's organizational members include non-governmental professional certification organizations, professional societies, and service providers. Our members reflect a wide spectrum of professions, including health care, engineering, financial services, and information technology, among many others. Our founding organizations – the American Society of Association Executives (the leading organization for association management) and the Institute for Credentialing Excellence (the leading developer of accreditation standards for professional certification programs) – govern the PCC.

The PCC supports reducing unnecessary barriers for licensed professionals who move to a new state. However, as noted in the attached [Statement of Principles](#), not all state-specific requirements are unwarranted: substantive state-specific licensing requirements protect the public from unqualified or unethical practitioners and uphold the integrity of licensed professions as a whole.

Under existing law, a licensing board is authorized to issue a provisional license or certificate to an individual with an out-of-state license while the individual is awaiting on a decision on their application for full licensure or certification. In its current form, H.B. 1179 would require that a board *automatically* issue a license or certificate to such an individual — with an out-of-state license or certificate and a provisional license or certificate in Indiana — if the board has not acted on the individual's application before the expiration of the provisional license or certificate, regardless of whether the individual meets the qualifications for such license or certificate.

Accordingly, the PCC urges the legislature to amend H.B. 1179 to ensure that the standards for Indiana licensure are maintained. Specifically, the PCC proposes that IC 25-1-21-7(g) be amended to

read “The board shall make a final decision on a license or certificate application before the expiration of a provisional license or provisional certificate issued under this section. If the board does not make a final decision on a license or certificate application before the expiration of a provisional license or provisional certificate, **the provisional license or provisional certificate will be automatically renewed for one year.**”

This bill directly affects protections for the public and also for PCC members that confer credentials to professionals in regulated occupations, such as health care, in which certification by recognized private certification organizations is a condition of licensure. If, due to variations in licensing laws, reciprocal licensure allows unqualified or unfit individuals to practice, the public’s trust in certified professionals and their regulated professions will be irreparably damaged, especially for occupations in which the public conflates certification status with licensure. The COVID-19 pandemic caused staffing shortages and workplace disruptions across sectors – including state agencies – that at times slowed the pace of expected workflows. While the PCC commends H.B. 1179 for attempting to ensure that such delays do not unduly prejudice applicants for licensure, neither should staffing issues result in conferring an Indiana license on potentially unqualified individuals.

Even PCC members that issue certifications to individuals in fields that do not require licensure have an interest in this issue. Certification organizations – and professional societies that represent individuals who hold certification credentials – rely on licensing agencies to protect the public. Our members are also interested in upholding professional standards for knowledge, skills, conduct, and qualifications. If alternative pathways to licensure create loopholes that weaken how state licensing agencies enforce such standards, this is a matter of great concern to the certification community.
