Re: L.D. 1586 (H.P. 1031)

Dear Representative Smith:

The Professional Certification Coalition (PCC)¹ writes to share our views regarding L.D. 1586. The PCC urges an amendment to ensure out-of-state applicants for licensure are not held to materially lower standards than Maine expects of its own residents.

The PCC supports reducing unnecessary barriers for licensed professionals who move to a new state. However, as noted in the attached [Statement of Principles](#), not all state-specific requirements are unwarranted: substantive state-specific licensing requirements protect the public from unqualified or unethical practitioners and uphold the integrity of licensed professions as a whole.

For certain occupations, Maine requires applicants to earn a private professional certification to demonstrate that they have achieved the core knowledge, skills, and competencies for that occupation. L.D. 1586 would permit unqualified individuals to apply for a license and hold themselves out as qualified, despite not having demonstrated the skills and knowledge required to earn the requisite private certification. This puts Maine residents at risk. A history of employment alone does not prove the competency and skill levels expected of licensed professionals in Maine, and not all private certifications are comparable to each other or equivalent to those that Maine residents are required to hold as a condition of licensure. We therefore urge that L.D. 1586 be amended to require that applicants hold the private certification that Maine licensing laws otherwise require for that occupation.

Specifically, the PCC urges the legislature to amend Section §18711 to add a new subsection 5: **“5. Sections 18702 – 18705 shall apply to any occupation in this state for which the licensing requirements include that the applicant holds a valid and current private certification as a condition of licensure, only if the applicant currently holds that private certification. Where a licensing law in this state specifies either a private certification or other substantive qualifications as alternative eligibility standards for a license, an out-of-state**

applicant must either hold that current and valid private certification or demonstrate qualifications at least equivalent to the alternative eligibility standards required of Maine residents.”

This bill directly affects protections for the public and PCC members that confer credentials to professionals in occupations in which certification is a condition of licensure. **If, due to variations in licensing laws, L.D. 1586 allows unqualified or unfit individuals to practice, the public’s trust in certified professionals and their regulated professions will be irreparably damaged, especially for occupations in which the public associates an individual’s status as a certified professional with licensure.**
