Re: SB 78

Dear Senators Meredith and Richardson:

The Professional Certification Coalition (PCC)¹ writes regarding SB 78. We respectfully request that the Kentucky legislature amend the bill to remove any prohibition on consideration of board certification as part of credentialing, participation, reimbursement, or enhanced reimbursement decisions for health care providers. Removing this one-size-fits-all prohibition will permit organizations charged with ensuring individuals' health to continue to make free market decisions.

The PCC recognizes and supports the goal of ensuring that credentialing criteria used by insurers, managed care plans, and entities that employ health care providers (e.g., health maintenance organizations, nonprofit hospitals, and medical-surgical, dental, and health service corporations), are objective and relevant to the services provided by health care providers. We further agree that health care providers should not be excluded from participation based on geographic location, the treatment of high-risk populations, past health conditions, or current health conditions that are not relevant to the health care provider's ability to provide safe, competent, and relevant care. These principles are important to maintain fair and nondiscriminatory access to employment and to provider networks.

However, SB 78 goes beyond these objectives by categorically prohibiting insurers and employers from requiring board certification as a condition of credentialing, participation, reimbursement, or employment for a wide range of health care professionals, including physicians, podiatrists, dentists, chiropractors, psychologists, home medical services providers, advanced practice nurses, optometrists, pharmacists, and physician assistants, and any other occupation defined as a health care provider under applicable regulations. Board certification is widely recognized as demonstrating a board certified provider's training, knowledge, and competencies within the scope of their credential. In many contexts, it also serves as one of several tools that insurers and employers legitimately use to assess provider qualifications and

quality. For example, for the physician and pharmacist professions, “board certification” refers to specialty certifications, representing advanced training and experience beyond the generalist level needed for state licensure. There are legitimate reasons that a hospital may include a specific specialty board certification as a required qualification for particular jobs that call for objective measures of advanced or specialized expertise. Indeed, the Accreditation Council for Graduate Medical Education (ACGME)’s requirements for a hospital to have an accredited residency program include that physician faculty members must generally hold current board certification in their specialty.² Yet as currently drafted, S.B. 78 would prohibit the hospital from making hiring choices on that basis.

In addition, for some non-physician health care professions, board certification is required under Kentucky law for both initial licensure and for renewal of licensure, as with physician assistants (see K.R.S. 311.844(3)(c)). Thus, Kentucky hospitals and health services corporations employing of physician assistants must by law “require a health care provider to be board certified,” which S.B. 78 in its current form would prohibit.

But even where a decision to include board certification as a job qualification is not required by law or to satisfy accreditation standards, the legislature should not interfere with a health care employer’s assessment of what qualifications will best enable the employer to meet its hiring needs. Similarly, the legislature should continue to allow insurers to consider recognized professional credentials as part of an overall, nondiscriminatory credentialing framework. A balanced approach should permit insurers to evaluate multiple, relevant indicators of provider competence rather than mandating a one-size-fits-all prohibition. It is inappropriate for legislation to intervene in free market decisions of this nature.


Specifically, the PCC urges the following amendment:

- Remove the amended subsection (3)(d)(2) by deleting paragraph c., which prohibits requiring a health care provider to be board certified.
